3. Trade Fair Commencement Date: 04.11.2026, from 10:00 a.m.
4. Trade Fair Closing Date: 06.11.2026, till 03:30 p.m.
5. Deadline for Confirmation of Participation: 7 days.
6. Deadline for refusal of Confirmation of notification: 7 days.
7. Assembly day: 03.11.2026, from 08:00 a.m. to 08:00 p.m.
8. Disassembly day: 06.11.2026, from 03:30 p.m. to 10:00 p.m.
9. Due date for payment of fees in accordance with clause 3.3: 7 days from the acknowledgement of receipt.
10. The due date for the payment of fees under clause 3.4:
  - a. instalment 1 in the amount of 45 % of the gross payment resulting from the order in the Exhibitor Panel, paid as an advance 7 days from the confirmation of the acceptance of the application;
  - b. instalment 2 the remaining part of the total gross payment resulting from the order in the Exhibitor Panel to be paid by 23.10.2026 prior to the occupancy of the exhibition stand.
11. Deadline for cancellation of participation in the Fair as referred to in clause 4.1 and 4.2 of the Regulations: 04.09.2026.

- 14.4. In the event that the Trade Fair is cancelled for the reasons referred to in clause 14.1, the Exhibitor waives its claims for reimbursement of the mandatory Exhibitor Registration Fee. This amount represents a partial settlement of the costs of organising the Trade Fair by TwK. The remaining amount of the Fees paid by the Exhibitor shall be refunded within 30 days of the cancellation of the Trade Fair or, at the Exhibitor's request, may be credited towards participation in the next edition of the Trade Fair.
20. The amount of the fee for each commenced man-hour of extension of the assembly day: NET 850 PLN (in words: eight hundred fifty PLN) + VAT at the applicable rate.
  21. The amount of the fee for each commenced working hour of extension of the disassembly day: NET 850 PLN (in words: eight hundred fifty PLN) + VAT at the applicable rate.
